And whereas, it is considered necessary to provide opportunity to all the workers/employees working in all Shops and Commercial Establishments to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes 'Sunday' the 10.05.2026 to be the **holiday with wages** for all Shops and Commercial Establishments falling within the jurisdiction of the State of Haryana for only those who are enrolled as voters in above mentioned jurisdiction to enable them to cast their vote.
