Subject: - Regarding issue of Outstanding Income-Tax Demands.

Sir/Madam,

I am directed to invite your attention to the communication received from the Office of the Commissioner of Income Tax (TDS)-2 regarding outstanding income-tax (TDS) demands pertaining to various Departments of the Government of Haryana.

2 As reported by the officers of the TDS wing of the Income Tax Department, substantial demands are pending in a large number of cases. Despite issuance of statutory notices, repeated reminders, meetings with concerned officials, as well as follow-ups through emails and telephonic communication, no response has been received in the majority of cases. Such non-responsiveness is a matter of serious concern, particularly in view of the fact that statutory notices issued under the Income Tax Act mandate time-bound compliance.

3 At present, a total of 2,167 cases involving an amount of ₹152.84 crore are outstanding (details enclosed at Annexure A & B).

4 It is, therefore, requested to kindly direct the officers concerned under your administrative control to take immediate necessary action to verify and deposit the outstanding demands positively by 25.03.2026, failing which further action may be initiated by the Income Tax Department, as per law. The officials concerned will be responsible for any liabilities imposed by the Income Tax Department.

I have assumed charge as Commissioner of Income-tax, TDS-2, Chandigarh on 16.02.2025. I take this opportunity to convey my greetings to you. I look forward to working in coordination with you in furtherance of department's objective related to tax deduction as well as tax collection at source.

2. Tax deduction at source is a powerful yet non-obtrusive instrument for revenue collection, widening tax base, and preventing tax evasion. TDS collection contributes a significant percentage to the All - India total budget collection and the contribution is increasing year after year. TDS charge has continuously been playing an important role to ensure compliance by Government Principal Accounts Officers/deductors and also in capacity building of stakeholders. TDS charge is also a key role player for monitoring of autonomous bodies, PSUs and State Government entities.

3. I invite your personal attention to the issue of **outstanding income-tax demands** in respect of several departments under the Government of Haryana such as State Govt. Distt. Food and Supply Controller, Mining Officer, Department of Mines and Geology, Panchkula, District Revenue Officer, Yamuna Nagar etc. A list of all such cases is attached.

4. The officers of TDS wing of the Income Tax Department under my charge have reported that **substantial demands are outstanding** in these cases. Despite issuance of statutory notices and subsequent reminders, meetings with concerned persons, e-mails and phone calls made by the officials of the Department, no response has been received in majority of the cases. Non-responsiveness is a matter of concern, particularly as statutory notices issued under the Income-tax Act require time-bound action. As per the Income Tax Act, the next course of action available to the officers is attachment of bank accounts. However, this can be avoided with your kind intervention.

5. As per the Central Board of Direct Taxes (CBDT) guidelines, outstanding demands are broadly classified as **undisputed** and **disputed**. Undisputed demand is required to be paid within the time specified in the demand notice (i.e. within 30 days), failing which interest and further proceedings follow as per law. In cases where the demand is disputed, the assessee may file appeal and seek stay of demand in accordance with CBDT instructions, which generally require deposit of the prescribed percentage of the outstanding demand and filing of a stay application before the Income Tax Authorities.

6. A Department-wise statement of outstanding demand along with the present status is enclosed for your ready reference as Annexure-A and Annexure-B. The total cases are 2167 with a total amount of Rs.152.84 Cr.

7. I request your kind intervention to direct the head of the concerned departments to treat the matter as **urgent**, and necessary directions may be issued to the concerned officers to deposit the demands by 25.03.2026.

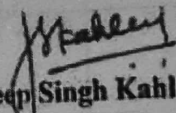

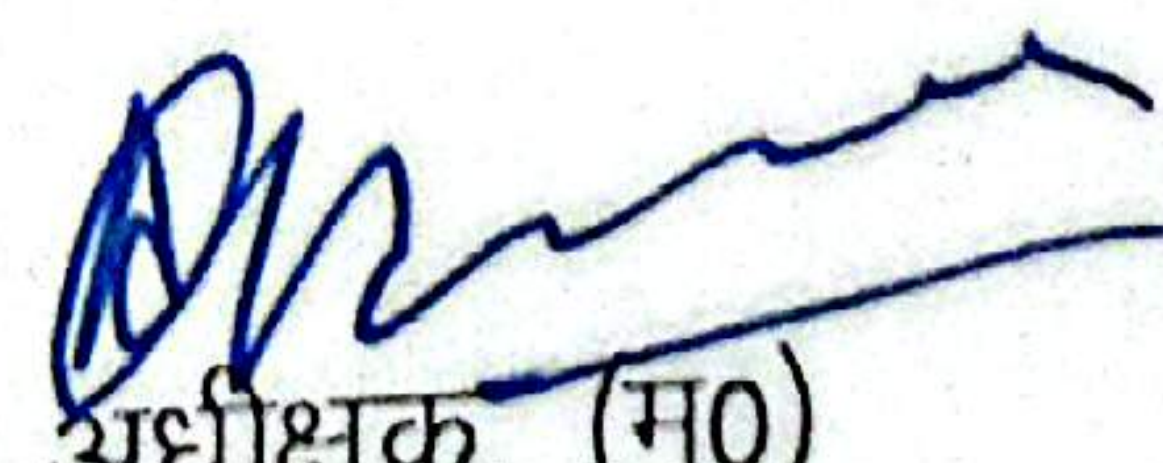
