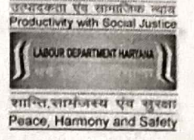

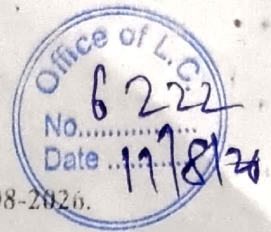

Now, the State Government has decided to extend the timelines of the web portal (www.securedemployees.csharyana.gov.in) under the Haryana Contractual Employees (Security of Service) Act, 2024 and Rules, 2025, accordingly, the revised schedule for completion of the process at various stages shall be as under:-

Stage	Timeline
Candidate Registration on the Portal.	Up to 31-08-2026
Verification by DDO.	Up to 10-09-2026
Verification by HOD (on applications received from DDO)	Up to 20-09-2026
